City Clerk, Donna Grider gave the Oath of Office to the five new Council Members.

SPECIAL ORDERS OF THE DAY

City Clerk, Donna Grider called for the election of the Mayor.

1. Election of Mayor and Vice Mayor

MOTION: Council Member Klein nominated Council Member Burt for Mayor.

Council Member Klein spoke regarding his nomination of Council Member Burt for Mayor for 2010. He spoke about his accomplishments that include being a star athlete at University of California-Santa Barbara, Founder/President of Acteron which has won numerous awards for clean technology. He spoke about his years as a Commissioner on the Planning and Transportation Commission.

At this point a paper ballot was conducted.

Council Member Holman stated her support of the nomination. She stated she has experienced his expertise, knowledge and dedication to public process while serving with him on the Planning & Transportation Commission. She expects the new Mayor to lead the Council with further transparency, open government and a proactive approach when having to deal with project evaluation process.
