Appointment of Three Candidates to the Historic Resources Board and Four Candidates to the Parks and Recreation Commission (PARC) for Terms Ending December 15, 2019; and Discussion and Potential Appointment of one Candidate to the PARC for an Unexpired Term Ending December 15, 2018

On Monday, January 9, 2017 the Council is scheduled to appoint three candidates to the Historic Resources Board and four candidates to the Parks and Recreation Commission (PARC) for terms ending December 15, 2019. Council is also scheduled to discuss the unscheduled vacant term on PARC ending December 15, 2018 and potentially appoint a candidate to this term. Voting will be by paper ballot.

Background

On November 30, 2016 the Council interviewed 4 applicants for the Historic Resources Board and 6 applicants for the Parks and Recreation Commission.

On December 19 2016, the Clerk's Office learned that Jim Cowie resigned from the Parks and Recreation Commission (PARC). His unexpired term on the PARC expires December 15, 2018.

Historic Resources Board

Vote to appoint three (3) three-year terms on the Historic Resources Board (HRB) expiring on December 15, 2019. The first three candidates to receive at least five votes (required) will be appointed.

The 3 HRB Candidates are as follows:

- 1. Bower, David (Incumbent)
- 2. Bunnenberg, Beth (Incumbent)
- 3. Corey, Brandon
- 4. DiCicco, Patt (Incumbent)

Parks and Recreation Commission

Vote to appoint four (4) three-year terms on the Parks and Recreation Commission (PARC) expiring on December 15, 2019. The first four candidates to receive at least five votes (required) will be appointed; and

Potentially, vote to appoint one (1) unscheduled vacant term on the PARC expiring on December 15, 2018. The first candidate to receive at least five votes (required) will be appointed.

- 4. McCauley, Ryan
- 5. Reckdahl, Keith (Incumbent)

The Historic Resources Board recently reviewed a project in Professorville that proposed to remove much of the "historic fabric" (moldings, porches, octagonal eating room) of a 90+ year old residential building and replace them with modern architectural features. This project would have seriously damaged the building architecture and diminished the historic district character.

3. If appointed, what specific goals would you like to see the Historic Resources Board achieve, and why? How would you suggest accomplishing this?

I'm pleased that the Historic Resources Board has created design guidelines for presentation to the city council for approval. I'd like to see the board work to strengthen the incentives to retain and repair residential buildings.

There are several projects that are examples of good historic architecture. The Avenitas Center (the original police/fire building), the Ramona Street Historic District, the Peninsula Art League building (at the corner of Romana Street and Forest Avenue), the Cardinal Hotel accross the street from the city hall.

A recent project to the ARB involved a non historic commercial building downtown that was surrounded by small historic structures. This project was not referred to the Historic Resources Board. It is essential that projects next to and across the street

from historic structures be examined for compatibility with the historic structures. These

particular historic structures are Birge Clark building and early residences. If we ignore such buildings soon the whole unique charm and success of our downtown will be lost.

I am concerned with moving and re- orientating of historic structures on their lots. I am concerned with the loss of historic fabric(building materials.- shingles, studs decorative moldings) and replacement with new materials.

I am concerned that large additions, and changes to facades will cause the loss of integrity to our historic districts and eventually the loss of historic status.

3. If appointed, what specific goals would you like to see the Historic Resources Board achieve, and why? How would you suggest accomplishing this?

I would like to see a review or survey of our current historic inventory to see if the Categories are appropriate for today's standards. Perhaps make every thing Cat. $\bf 1$ or $\bf 2$.

I would like to see stricter monitoring of construction to prevent loss of historic fabric and training of on the job workers to recognize historic fabric. (such as that which happened in Edgewood Plaza.)

I would like to see stronger control of moving historic structures on the site (such wording is available in the New (suggested)Guidelines for Professorville Some changes may be needed in the Historic Preservation Ordinance.

Rinconada Library- 1213 Newell. Later addition skylights were removed to return the roof to original state. the new addition is very respectful of the original building but does not mimic

it. The entry on the side near the Art center has a mid century Modern feel and a welcoming experience.

The Palo Alto Sea Scout Base Palo Alto Baylands is a very successful conversion to the Eco Center and makes views of the baylands available to the public. The change in use is making a contribution to educating the community about the ecosystem and inportance of the bay.

As such, I am very concerned about what we put in guidelines, and I want to make sure we have a good document for people to refer to.

For full disclosure, I was not supportive of the document in it's current form, though supportive of the idea in general. I look forward to getting to the point where we have a document that everyone can agree on.

I would like to continue to work on and influence the Design Guidelines.

I would encourage and support taking this another step forward, and working towards historic design standards if the community feels that there could be a benefit in having these.

Both shingle style, wood panels and beamed ceiling in the downstairs "public areas", with large bedrooms and sleeping porches on the second floor. The combination of the hipped and bonnet style roof on the Fowler mansion works adds to it's character.

As a result the project was not approved and is currently in the appeal process

262 Kingsley in historic Prefessorville requested the HRB review a proposal to demolish an existing two car garage and rear portion of the existing home to be replaced by a one car garage and a large two story rear addition.

In this case the new addition was subordinate to existing structure built in 1908. With the Board approval the building was moved forward to accommodate the rear addition.

Most of the project met with the Secretary's Standards and afforded the family adaptable living space to accommodate their needs. A win, win situation.

I am interested in many issues detailed within the latest Master Plan draft that was presented during the 9/6/16 Master Plan Study Session. One issue of particular interest to many of our community's adult and youth soccer players and their families is "Policy recommendations for natural and synthetic turf fields".

An opinion shared by many within our community is that we should strive to improve the quality of our natural grass playing fields at Palo Alto Middle Schools and associated parks. While a number of community organizations have worked together with the City and have contributed substantial manpower and 6-figure financial resources over many years, the net results have been mixed at best. Many grass playing fields have subsisted with consistently poor to fair quality.

This is a complex problem involving the City, School District, multiple recreation organizations, competing agendas, and high use resources (grass fields) with constrained rest and maintenance windows. However, a focused, mid-term strategy, detailed and implemented within the Master Plan, can and should yield significantly improved results. Many community organizations are hungry for a mid-term plan to systematically improve our grass playing fields and are eager to assist the community in its implementation.

3. If appointed, what specific goals would you like to see the Parks and Recreation Commission achieve, and why? How would you suggest accomplishing this?

- Goal: Implementation and prioritization of the Master Plan. This is the vehicle that drives the bulk of the PARC effort.
- Goal: Encourage and improve walking and biking access to parks and recreation facilities. This benefits our environment, reduces traffic, promotes better health, and supports our Bicycle and Pedestrian Transportation Plan. Develop new "Safe Routes to Parks" connections, building upon the successes of the Safe Routes to School program and following a similar implementation plan.
- Goal: Increase dedicated parklands within our community. Gaps have already been identified. Identifying and acquiring new parklands will be complicated, but must be pursued. Creative funding will be required. We should also assure the continued enjoyment of undedicated park resources by acting guickly and formally dedicating them.
- Goal: Broaden our urban canopy. This benefits our environment and community in many ways. Seek out and identify suitable sites for new trees. Ensure that appropriate species are planted and adequately cared for, including getting enough water.
- Goal: Add one or more community gardens in Mid-town and South Palo Alto. No community gardens currently exist in these areas and this is a community amenity which is often mentioned and requested by residents. Identify potential sites to purchase or lease. Get creative with funding sources as necessary.
- Goal: environmental stewardship and sustainable best practices for our open spaces. We must protect the cherished natural jewels of our city as outlined in the Master Plan.
- Goal: Improve grass playing field quality at Palo Alto Middle Schools and associated Parks (see Question #2 above).

Numerous issues before the Parks & Recreation Commission are of great interest to me, particularly the long-term Master Plan process. The most recent example is the dog park initiative. As a dog owner, I have had many great conversations with fellow dog owners since moving back to Palo Alto and have been impressed at how closely my neighbors are following the discussion. Our parks are truly "multipurpose" assets that many constituencies view as essential to our community. In my experience, pet owners in Palo Alto are incredibly responsible, but the question of whether to dedicate certain spaces for specific purposes (and which spaces) is just one aspect of the balancing that needs to be discussed in the broad conversation about how our parks and recreation programs serve our community.

3. If appointed, what specific goals would you like to see the Parks and Recreation Commission achieve, and why? How would you suggest accomplishing this?

First, as I noted above, I am continually impressed at the level of engagement among neighbors and friends who live and/or work in Palo Alto. The Master Plan process has sparked people to reflect on how their parks and recreation programs serve the community and how those assets can be preserved and improved upon in the future. I would like to see more ways for the community to provide their feedback, including additional survey tools and potential on-site discussion sessions focused on neighborhood needs.

Second, I am a firm believer that historical context is always helpful to our civic progress, particularly in Silicon Valley where people have migrated from all corners of the world. I would like to see an initiative to tell the story behind Palo Alto's parks. Interpretive signs would be a great addition for many of the assets in the parks and recreation sphere and the process of chronicling that history is a reward in itself that could further engage community members.




