NEW BUSINESS:

1. **300 Homer Avenue** [**10PLN-174**]: Request by the Palo Alto History Museum for Architectural Review and Historic Resources Board review of historic rehabilitation and rear addition to the historic Category 2 Roth Building, adding 1,462 square feet to the 19,182 square foot building. The application includes requests for a Conditional Use Permit request, Transfer of Development Rights (TDR) eligibility for approximately 4,796 square feet to sell to eligible receiver sites, and City Council amendment of the Option Agreement and Lease. Zone District: PF in the SOFA I CAP.

Staff Recommendation:

Staff recommends that the Historic Resources Board (HRB) and the Architectural Review Board (ARB) recommend to the Director of Planning and Community Environment (Director) approve the project for rehabilitation and modifications to the Roth Building, based on compliance with architectural review findings (Attachment A) and the Minor Exceptions findings (Attachment B) and subject to conditions of approval (Attachment C).

Ken Alsman, Stated his concern regarding the parking in the neighborhood.

Architectural Review Board Action:

The Board recommended approval of the project, (4-0-0-1, Board member Lee moved, seconded by Board member Young, Board member Wasserman was absent) with the following items to return to the ARB Subcommittee for further review:

- b) All doors, window details, and railings
- c) ADA parking and 2 hr parking
- d) East blank wall and roof behind
- e) Access signage
- f) Hours for the public restrooms
- g) Utilities condensing units
- h) cafe seating and other outdoor seating.
- 2. **Stanford University Medical Center Stanford Hospital [10PLN-00395]**: Request by Stanford Hospital and Clinics on behalf of The Board of Trustees for the Leland Stanford Junior University for Architectural Review of a new Stanford Hospitals and Clinics main hospital building, consisting of approximately 1,100,000 square feet of new hospital area, 456 replacement hospital beds, the addition of 144 new hospital beds, surgical operating suites, diagnostic and treatment suites, emergency department, nursing and support space. The project also include development of an above grade/below grade parking facility of approximately 970 spaces, site re-development and a new landscaping plan. This project is a component of the Stanford University Medical Center Facilities Renewal and Replacement Project. Existing Zone District: PF (Public Facilities).
