SUBJECT: **AGENDA ITEM NUMBER 6-** Utilities Advisory Commission Recommend the City Council Adopt the 2022 Annual Water Shortage Assessment Report

The 2022 Annual Water Shortage Assessment Report was presented to the UAC at its June 8, 2022 meeting. The UAC voted unanimously (6-0), with Commissioner Smith absent, to recommend Council adopt the 2022 Annual Water Shortage Assessment Report.

Commissioner Recommendation and Comments

- There was a recommendation to lower the staff estimate in Table 5 of the potential savings from restaurants and other food service operations serving water to customers only upon request. Staff will revise the estimated water savings attributed to this action.
- There was a concern that the current and staff proposed water use restrictions would not be enough to close the shortage gap projected for FY23.
- There was a comment that water use reduction measures should not be too restrictive and should provide residents with enough water for tree health.
