

OVERVIEW

- City's Local Emergency Proclamation was issued March 12, 2020, and affirmed on March 16th due to the worldwide COVID-19 pandemic.
 - Under this proclamation the City has implemented certain programs and policies.
 - This item outlines next steps should the emergency proclamation be rescinded (e.g. encroachment permits and parklet program).
- Additional information, including traffic data, is provided to aid the Council in discussion and direction to staff on street closures.



RECOMMENDATION

Staff recommends the City Council:

- 1. Consider whether to continue or rescind the City's Local Emergency Proclamation
 - The City Council could:
 - 1. Rescind the local emergency effective immediately.
 - 2. Rescind the local emergency later this summer, either on a date certain or if certain metrics are reached.
 - 3. Allow the local emergency to continue.

If the Council rescinds the emergency effective immediately, staff recommend adopting the emergency ordinance in order to continue outdoor encroachment permits, parklets, etc.

2. Discuss and provide direction to staff on street closures.

- States of Emergency presently continue at all levels of government, subject to change.
- Emergency proclamation dates (right).
- State continues to provide guidance on protocols and adjustments to limit the spread of the virus.

CALIFORNIA RE-OPENING - JUNE 15, 2021

- The color-coded tier system for California counties ended June 15, 2021.
- Generally, businesses can open indoors without capacity restrictions.
 - State guidance and protocols require some adjustments.
 - Refinements are expected to continue.
- The Governor has not ended the state of emergency.
- Santa Clara County has a very high vaccination rate.
 - Fully vaccinated: **71.2**%
 - Partially vaccinated: 80%




STREET CLOSURES

- In April 2021, Council extended the City Manager's authority to close certain streets until October 31, 2021.
- Since that time, the contours of the pandemic have changed significantly—with positive improvements.
- Given shifting context, staff are seeking further Council direction regarding the street closures.

STREET RE-OPENING OPTIONS

- 1. Continue closures until October 31, 2021.
- 2. Re-open Streets on Specific Date(s)
 - 1. Downtown on **July 6** (including Ramona St.)
 - 2. California Avenue on **September 7**
- 3. Re-open one street; keep one street closed.





PERSPECTIVES ON STREET CLOSURES

Continue Closures

- Pleasant pedestrian and cyclist environment
- Enjoying the nice climate
- Enjoying the "postpandemic" summer
- Car-free environment is safer for kids
- Indoor dining hesitancy and/or prefer outside seats
- Employment provided by restaurants more than retail

Open Streets

- Other Bay Area retail locations seeing gains; closures are cause of limited recovery.
- Pedestrians not on sidewalk limits retail sales
- Closures benefit restaurants more than retail
- Restaurants have had sufficient time to benefit
- Retailers suffer from limited vehicle traffic
- Proximate parking important





CORRESPONDENCE ON STREET CLOSURES

Public

- 406 emails preferring continuing street closures.
 - Closures create safer streets, provides safety for diners, pedestrians, and cyclists.
- 4 emails preferring open streets to traffic and/or more engagement with community before deciding.
- Over 1000 survey responses (April) supporting closures.

Business & Property Owners

Cal Ave

- **3 emails** support continuing closures.
- 4 emails supported the opening of the road to traffic.
- To promote drive-by traffic, get pedestrians on the sidewalk.

Downtown

- **12 emails** supported keeping the road closed to vehicles.
- **13 emails** supported opening the road to traffic.





COMPROMISE

- City staff have considered approaches to street closures that might facilitate the "best of both" options.
- Options considered include:
 - Weekend Only Closures Current staffing capacity cannot accommodate this option
 - Re-Striping University This creates minimal additional room for parklets while deteriorating the recently paved street.
 - One Lane on University This requires additional costs to the city (barriers, striping, etc.) and minimal increase in dining space.
 - Encouraging Pedestrians to Sidewalks Getting pedestrians to use sidewalks may be difficult; further there is a preference to continue the center lane for emergency access.

PLANNING FOR POST-COVID CONDITIONS

- Council has approved funding to pursue opportunities to create more flexibility in closures that could occur beyond the pandemic.
 - Ideas include retractable/removable bollards to facilitate flexibility, like weekend only closures.
- To facilitate closures of public streets, the City must comply with State Vehicle Code 21101.
 - This process includes environmental review under the California Environmental Quality Act.
 - The Council would have to find that the street is no longer needed for vehicular traffic.
 - Frequent weekend closures also have a process (VC 21101 (e)) + environmental review.
- Funding plan for capital and operating costs must be identified.
 - Likely involves assessment of construction costs to adjacent properties
 - Likely involves "rental" fees for use of public space
- City will engage stakeholders in an urban design process.
- The design and implementation processes will extend beyond October 31, 2021.



INTERMEDIATE STEPS & MILESTONES

- Finalizing scope of work and selecting consultant to develop a vision for street activation and design.
 Consultant on board this fall.
- Allocating staff project management resources.
- Coordinating between community stakeholders (residents, retailers, restauranteurs, property owners, and visitors) and city departments.
- If improvements are ultimately district funded, business engagement and bridging individual interests will be critical to a successful planning effort.
- Immediate decisions set the "status quo" for this significant work.



Discussion & Recommendation

RECOMMENDATION

Staff recommends the City Council:

1. Consider whether to continue or rescind the City's Local Emergency Proclamation

The City Council could:

- 1. Rescind the local emergency effective immediately.
- 2. Rescind the local emergency later this summer, either on a date certain or if certain metrics are reached.
- 3. Allow the local emergency to continue.

If the Council rescinds the emergency effective immediately, staff recommend adopting the emergency ordinance (4/5 vote required) in order to continue outdoor encroachment permits, parklets, etc.

2. Discuss and provide direction to staff on street closures.
