Dear Mayor Drekmeier:

This letter revalidates the determination for properties and/or structures referenced in the community as described in the Letters of Map Revision Based on Fill (LOMR-Fs) and Letters of Map Amendment (LOMAs) previously issued by the Federal Emergency Management Agency (FEMA) on the dates listed on the enclosed table. On May 8, 2009, we notified you of the administrative action taken to prevent valid LOMAs and LOMR-Fs from being superseded by the new FIRM for your community that became effective on May 18, 2009.

This letter is written to include 5 LOMCs that were inadvertently left off of the LOMC-VALID letter. The table includes LOMR-Fs and/or LOMAs not included on the revalidation letter previously issued, dated May 8, 2009, Case Number 07-09-1030V. As of the effective date shown above, these LOMR-Fs and LOMAs will revise the effective National Flood Insurance Program (NFIP) map dated May 18, 2009, and will remain in effect until superseded by a revision to the NFIP map panel on which the property is shown.
